

For the information of the FBI Laboratory and Latent Fingerprint Sections, on 8/15/78, at about 2:23 a.m., a fire was discovered at the PG&E Office building by a passerby who reported this to the Berkeley Police. He described it as looking like a "sparkler" (like on the described it as looking like a "sparkler" (like on the fourth of July) with small flames. It did burn brightly and was later extinguished by a resident of the apartment and was later extinguished by a resident of the apartment house next door, who said the flames were yellow-orange in color, shooting to an approximate height of 15 feet. The type of fire extinguisher used was a FireMaster, Type II-A, Soda-Acid.

Items #1 - 10 have been sent to the Laboratory in the original containers used by the Berkeley Police Department inasmuch as initial examination indicated various and often pungent odors present in the evidence which could be lost if the materials had been transferred to plastic bags for shipping to the Laboratory.

COUPEZ admitted taking part in all of the captioned cases, along with other unnamed George Jackson Brigade members. Therefore, the titles of all of the 174 cases has been changed in this report and each case is being placed into a closed status.

Synopsis:

George Jackson Brigade (GJB) members JOHN WILLIAM SHERMAN, THERESE ANN COUPEZ, and JANINE DARCY BERTRAM were arrested by FBI Agents at Tacoma, Washington, on 3/21/78. 3/28/78, a nine count Federal Grand Jury (FGJ) Indictment was obtained in the Western District of Washington, Seattle, Washington, against the three subjects, charging them with Conspiracy, Armed Bank Robbery, Bombing Matters, and Possession of an Illegal Bomb Device. On 6/8/78, BERTRAM pled guilty to two counts of the Indictment. A trial for SHERMAN and COUPEZ took place in U. S. District Court, Seattle, Washington, from 6/21/78 through 7/11/78 and both were found guilty of eight counts of the Indictment, while one count was dismissed. SHERMAN and COUPEZ were sentenced on 8/2/78 and BERTRAM was sentenced on 8/7/78. A copy of the FGJ Indictment and a copy of Judgment and Commitment for the subjects is attached to this report.

DETAILS:

On March 21, 1978, JOHN WILLIAM SHERMAN, THERESE ANN COUPEZ, and JANINE DARCY BERTRAM, all members of the George Jackson Brigade (GJB), were arrested by Special Agents of the Seattle, Washington, Division of the Federal Bureau of Investigation at Tacoma, Washington. They were subsequently transported to Seattle, Washington, and afforded an initial hearing before United States Magistrate PHILIP K. SWEIGERT. Following the initial hearing each subject was incarcerated at the King County Jail, Seattle, Washington.

On the same date a true bill was returned against three members of the George Jackson Brigade, JOHN WILLIAM SHERMAN, THERESE ANN COUPEZ, and JANINE DARCY BERTRAM. The three were charged with nine counts, including one county of Conspiracy, four counts of Armed Bank Robbery, three counts of Bombing Incidents, and one count of Possession of an Illegal, Unregistered Bombing Device.

On June 8, 1978, Assistant United States Attorney JERALD E. OLSON, U. S. He advised that her guilty plea was given before United States District Judge WALTER T. MC GOVERN, Western District of Washington, Seattle, Washington. The sentencing date for BERTRAM has been set for July 11, 1978.

On 7/11/78, JOHN WILLIAM SHERMAN and THERESE ANN COUPEZ were found guilty in U. S. District Court, Scattle, Washington. They were charged with a nine count Federal Grand Jury Indictment. The counts included one count of conspiracy, four counts of armed bank robbery, three bombing incidents and one count of possession of an explosive device. During the trial which began on 6/21/78, the one count of possessing an explosive device was dismissed. The verdict reached on 7/11/78 found both defendants guilty of each of the remaining eight counts of the Indictment.

The trial was presided over by Federal District Judge LEO BREWSTER.
