Montgomery County, Maryland, Fire Department Dedicates New Bomb Squad

On Monday, January 12, 1998, the Montgomery County, Maryland, Department of Fire and Rescue dedicated a new bomb squad. Montgomery County is located immediately west and north of the District of Columbia. The unit, which became fully operational on January 1, is the primary response team for handling incidents when suspected explosive devices are reported in the county. Designated as Special Unit 91, the team will respond to incidents of confirmed, suspected, or suspicious packages or devices. When requested, it will also respond to large fires, dignitary protection details, and explosive-related incidents in other local jurisdictions.

The 6-member team includes specially trained fire investigators and bomb technicians with the Montgomery County Department of Fire and Rescue Services. Members are Maryland law enforcement officers with police powers who are trained in explosives handling by the FBI and the U. S. Army at the Redstone Arsenal in Huntsville, Alabama. Bomb technicians receive 160 hours of basic training in the 4-week course that includes explosive handling and demolition. In addition, members of the team must receive 16 hours of additional training monthly and complete a 2-week refresher course every two years.

A converted ambulance is used by the team to carry the basic equipment required by the FBI to safely handle explosives incidents. Among the materials are four full protective bomb suits, two X-ray systems, tool kits, demolition kits, one robotic arm, one protective blast shield, three explosive disrupter systems, and one containment vessel/trailer.

Prior to the unit's creation, all bomb-related incidents in Montgomery County were handled by the Office of the State Fire Marshal. During the past two years, there have been more than 200 such incidents in the county. Much of the equipment was purchased through public donations and departmental support.

Northern Indiana Commuter Transportation District Auto Thefts Decrease

The recent capture and arrest of Larry Hunter, a man charged with 24 auto-related crimes 24 since 1977 and convicted of eight has made Chief Robert Byrd of the Northern Indiana Commuter Transportation District optimistic that the NICTD's auto theft rate will continue to decline. Hunter's arrests were often preceded by high-speed chases. His lack of resistance, unwillingness to use a weapon, and absence of confrontation kept his bonds low. Subsequent to his most recent arrest in June of 1997, Hunter pled guilty to six cases pending against him and was given a 9-year sentence. According to Chief Byrd, the NICTD case was the strongest of the six cases pending against Hunter.
