#### Disasters declared in Indiana and Ohio after severe storms and floods

Severe thunderstorms, high winds and record rainfalls during the July 4th holiday weekend left hundreds of north central Indiana residents and businesses flooded. The record rainfall also resulted in flooding of local streets, basements and homes along the Wabash River, which overflowed its banks after the heavy storms. Many residents were forced to evacuate their homes due to the water and storm damage. The resulting damage and cleanup from the storms prompted Indiana Governor Frank L. O'Bannon to request federal assistance to help with the costs of recovery . On July 11, President George W. Bush declared 34 Indiana counties a federal disaster area (DR-1476), allowing FEMA to provide federal assistance to Indiana homes and businesses in the affected counties.

Region personnel in conjunction with Indiana State officials began the recovery process immediately following the declaration, opening a Disaster Field Office (DFO) in the town of Kokomo on Sunday, July 13. Teams of Community Relations Officers were dispatched to the affected areas to inform residents about the process to apply for federal benefits, providing fliers and information through a variety of local volunteer agencies, businesses, churches and other community and county organizations. Disaster Relief Centers (DRC) are expected to open in several counties to allow residents access to SBA officials and other organizations providing assistance.



In west central Ohio, six counties experienced severe flooding as a result of the same storms that swept across Indiana. Ohio Governor Bob Taft requested and received federal disaster assistance for six counties (DR-1478) on July 15 to receive individual assistance. A Disaster Field Office (DFO) was established in the town of Cridersville and FEMA personnel were deployed to begin the recovery process.

### FEMA Fire Grant helps build new facility for first responder training

On July 19, 2003, the first class of the McDonough County Emergency Responder School was held in Macomb, Illinois. The school's unique design is a direct result of input from local fire departments, Macomb Police Department, McDonough District Hospital, and Spoon River College. Topics and activities of the school will help develop and sharpen skills and knowledge of all emergency responders and community leaders.

The First Responder School was funded in part from an Assistance to Firefighters Grant of \$49,275 awarded to the Macomb Fire Department as part of the 2002 program. The funds, along with additional money from the city of Macomb, were used to help build the state-of-the-art facility which boasts a hose, ladder, Self-Contained Breathing Apparatus drill structure, training mobile home, and other facilities.

More than 150 firefighters and first responders attended the school according to Lt. Roger Lunt, school director and Macomb firefighter. The First Responder School attracted local departments from Illinois, Iowa, and several other states. Topics in the school include fire ground basics, lifesaving drills, pump operations, hazards and treatment of injuries, and fire scene management. Instructors at the school are a cross-section of emergency and firefighting professionals, many of whom are from the University of Illinois Fire Service Institute.

The first class began with a special presentation from Chief Mark Wessel of the Keokuk, Iowa Fire Department. Chief Wessel, President of the Iowa Association of Professional Fire Chiefs, discussed the issues surrounding an incident in which three Keouk firefighters were killed. At 1:00 P.M. a ceremony was held commemorating the opening of the First Responder School. Members of the Western Illinois University (Macomb) Band played the national anthem as the American flag was raised over a small monument at the entrance to the school. The opening ceremony was attended by local, county, and state officials, as well as representatives of Congressman Lane Evans.

Among the dignitaries present at the dedication were State Senator John Sullivan, McDonough County Board Chairman Bob Harwick, Jay Franey from the Illinois Office of the State Fire Marshal, and honorary guest 8-year-old Rhett Fink, who is a frequent visitor to the Macomb Fire Station with his grandparents whom he visits while in town.

# *Building renovation set at Regional Office*

General Services Administration is planning to renovate our building for the future relocation of the Bureau of Immigration and Customs Enforcement (BICE) which is now part of DHS. The first phase of the project is preliminarily scheduled to begin September 1 and involves the following activities:

- ----Demolition of the third floor Bartial demolition of the second
- -Partial demolition of the second floor
- -Partial demolition of the basement

-----Construction of a new emergency stairwell on the west-side of the building.

 Closure of LaSalle Street to begin construction of a new loading dock. The entrance to Immigration will remain open until a later phase of the project.
Restriction of the courtyard. The courtyard will be limited to regular deliveries and construction activities. Parking will no longer be available in the courtyard, but will be accommodated at the Federal Garage located at 450 S. Federal St.

An all-hands meeting was held on July 31, during which representatives from GSA and the construction contractors presented additional information and details about the building project. GSA and contractor representatives answered questions and listened to concerns from employees.

### Training increases employee knowledge of Social Security benefits

An "In-Service" training session was held at regional headquarters on July 23, to provide information regarding Social Security programs and benefits to employees. The session was arranged by Region V Training Officer Sharon Wolf and Mary Mahler, Regional Communications Director for Social Security who has been on special assignment to the region. The training was facilitated by Social Security Public Affairs Specialist Erin Conway, and covered a wide range of topics including the history of Social Security, retirement, survivor benefits and Medicare. Ms. Conway answered questions from the employees about pensions, eligibility, and benefits. She also provided booklets to each participant about the Social Security program.

Regional Director Ed Buikema attended the training and felt it was very beneficial. "Sessions like these are extremely valuable to help people better understand the Social Security system," Buikema said. "Retirement and benefits are issues we all need to consider, regardless of our age or how long we've been in the work force."

#### Quarterly RISC focuses on key preparation and planning issues

The quarterly Regional Interagency Steering Committee (RISC) meeting was held July 15-16 at Region V headquarters. Two topics, the National Response Plan (NRP) National Incident Management System (NIMS), and Catastrophic Planning highlighted the meeting. Bruce Pfaff and Jim Stone were facilitators in the Catastrophic Planning session which was designed to consider actions to address shortfalls and examine alternatives to traditional planning. Scenarios were discussed using examples of an earthquake in the New Madrid fault zone, and discussing the traditional response methods, as well as a more proactive pre-disaster response which would allow for improved identification of resources and capabilities with damage estimates.

The NRP discussion analyzed the baseline goals of the new plan and a "bridge" for transitioning from the current Federal Response Plan. Among the principles being considered are the role of state and local government authorities, primacy of preventing terrorism, the importance of effective communication, and a seamless transition between operations and authorities.

#### AVUE streamlines job application process

On Tuesday, July 22, representatives of AVUE Digital Services (ADS) came to the regional office to present information about the new FEMA job application system. The new system, which is now operational, provides on-line application capability to FEMA employees and streamlines the process of tracking applications. The system allows for entering KSA's, viewing posted job openings, applying for jobs and updating applications. Each employee can keep track of the status of jobs applied for within FEMA, and the site also has links to USA Jobs for applications with other federal agencies. The site will also allow employees to stop during the process and return to complete the application. Users of the system can also withdraw from consideration for a job to which they previously applied. Resumes or other electronic documentation may be attached to your profile.
