CURRENT HUMANITARIAN SITUATION

Security

• The USAID/Disaster Assistance Response Team (DART) reports that the security situation has deteriorated in Darfur, with violent incidents occurring with greater regularity. Attacks are occurring closer to towns even where the international humanitarian community and African Union (AU) are present. In addition, the U.N. Advance Mission in Sudan (UNAMIS) notes that the number of ceasefire breaches increased considerably during September and early October. These ceasefire violations have had a serious impact on the U.N.'s ability to deliver humanitarian assistance to affected populations.

Humanitarian Access

• On October 18, the U.N. and the Sudan Liberation Movement/Army (SLM/A) solidified an arrangement with the SLM/A regarding humanitarian principles and travel notifications. The SLM/A has agreed to allow national staff to travel without international staff. In addition, the U.N. Office for the Coordination of Humanitarian Affairs (OCHA) will continue to make introductions, facilitate exchanges, and mediate between non-governmental organizations (NGOs) and the SLM/A; however, NGOs will now be responsible for travel notifications and bilateral exchanges with the local SLM/A commander.

African Union

• On October 20, the AU's Peace and Security Council formally agreed to expand its monitoring mission in Darfur to 3,320 African troops, including ceasefire monitors, civilian police officers, and civilian staff. The first deployment of an additional 1,000 troops is expected to come from Nigeria and Rwanda. The additional forces are scheduled to be in the region by early November.

Health

According to the USAID/DART, during the first round of the polio vaccination campaign, the
U.N. World Health Organization (WHO) and the U.N. Children's Fund (UNICEF) immunized
46,943 children under the age of five in Geneina, West Darfur. The target population for the
polio vaccination campaign in West Darfur is 229,000 children under the age of five. A number
of areas, including Beida, Congo Hazara, and Kulbus, have not yet been reached due to militia
activity.

Nutrition

According to the USAID/DART, relief organizations operating feeding programs in West Darfur
report that the main child health issue is the lack of adequate pediatric medical care at the
community health center level, and not necessarily acute malnutrition. The USAID/DART
reported that relief organizations believe that feeding programs without adequate medical care at
the community level will not provide sustainable positive results.

Food Assistance

- From October 1 to 18, WFP distributed food to 632,228 of 1,660,228 planned beneficiaries for October. Beneficiaries are expected to receive a balanced ration this month. However, insecurity, including road closures and threats to WFP-contracted transporters, is affecting food distributions. Drivers are taking longer, alternative routes and sometimes traveling in convoys. WFP reported that since several areas in North Darfur have been declared "no-go" areas by the U.N., an estimated 160,000 people will not receive food assistance until the U.N. deems these areas secure.
- On October 19, the International Committee of the Red Cross (ICRC) reported that Darfur could have a food crisis worse than the famines in Sudan during the 1980s and 1990s. Only a third of the usual crops have been sown and a combination of insecurity and drought have destroyed traditional coping mechanisms.

Darfur Rapid Environmental Impact Assessment

• USAID/OFDA funded a rapid environmental impact assessment for Darfur conducted by CARE and the Benfield Hazard Research Center from September 10 to October 3. The assessment took place in Khartoum, Nyala, and Kala, Otash, and Bajoum IDP camps. The assessment determined that although IDPs depend on local natural resources, particularly trees and grass to meet current needs, the environmental impact is probably significant at a local level but will not result in any irreversible environmental damage if managed properly. Issues that require immediate attention include fire safety in camps, security in areas outside camps for wood and grass collection, the sustainable provision of water, and sustainable management of solid and liquid waste to reduce the opportunities for disease transmission.

Livestock Migration

According to the USAID/DART, OCHA is attempting to negotiate a south-north transit corridor
for camel migration, from the eastern side of Jebel Moon to the western side of Jebel Marra in
West Darfur. Historically, a "safe zone" policed by the Government of Sudan (GOS) allowed
uninterrupted transit between these areas. The migration is expected in December, and according
to the U.N. and NGOs operating in the area, if this transit corridor is not established, the
migration of camel and cattle herds during this period could potentially become a conflict
flashpoint and result in a new round of cattle and camel raiding.

Chad

• On October 22, WFP reported that the October food distributions are complete for all 11 refugee camps, including a general distribution to 186,335 beneficiaries and blanket supplementary feeding to 28,080 other recipients. According to WFP, some Chadian residents have attempted to register as refugees.
